The Project and Objective

CSIS is conducting a research project on the future of work in the developing world. The research and analysis will look at trends, the direction of the workforce, and will provide policy recommendations to help prepare us for the future. We will be convening a broad stakeholder working group to help inform our research. This meeting is a first scoping session which will help orient our thinking and our work over the coming 6-9 months. The working group will meet three times starting in May. Our findings will be presented in a final CSIS report in the late Fall 2018 that will be disseminated in the U.S. and abroad. As part of the research, CSIS will conduct 4 country case studies in Brazil, Indian, Kazakhstan and Nigeria.
